Item No 55.3	Report of the Director about the Progress of different Activities

Director presented his report providing the details of the activities which happened after the last BoG meeting. He explained about the Selection of Faculty and non-faculty members in the Institute and the other activities being undertaken by the Institute in different areas as follows:.

- Audit team visited during October-Nov and completed the transaction audit. There is no major findings as informed by them.
- Institute is going to organize several events in coming months:
 - 2nd IEEE International Conference on Computer Vision and Machine Intelligence (CVMI) is planned to be organized during 10-11 December 2023.
 - 2nd Atal Research & Innovation Conclave (ARIC-2023) is organized during 18-19, December 2023.
 - 2nd International Conference on Advances in Nanomaterials and Devices for Energy and Environment "CANDEE-2023 during 19-20 December 2023.
 - 2nd IEEE International Conference on Interdisciplinary Approaches in Technology and Management for Social Innovation (IATMSI-2024) during March 14-16, 2024.
- Selection Medical officer, Security officer, Librarian, Sr Technical Officer, and Technical officer (one post each) will be completed by December 24, 2023.
- Advertisements for Faculty positions are made, and last date is November 01, 2023. Selection is expected in 3rd/4th week of December 2023.
- Ordinances (BTech/IPG, MTech, MBA and PhD) are finalized and printed. The pdf versions are kept on website of the institute.
- Revised course curriculum with contents 2023 is prepared.
- Affidavits are taken from those students, who had less than 75% attendance till mid Sem examination, for completing the 75 attendances in the course to appear in the end Sem examination. The same is sent to their parents by the post.
- Advertisements for winter PhD and MTech admissions are made. MTech admission is completed, and PhD admission is to be completed by first week of December 2023.
- At present the highest placement package is 57 lakhs through on campus placement drive.
- Institute will have alumni day on 16th and foundation day on 17th January 2024.

The matter was deliberated and after discussion the Board agreed, under the given circumstances, with the proposed plan by the Director for completing the selection of faculty members to the post of Professors.

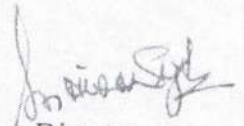


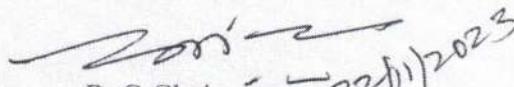

Item 47.4	Approval of Scholarship rules
------------------	--------------------------------------

The Senate in its 31st meeting held on 05.09.2023 approved the committee proposal on MCM scholarship being awarded to the student from 2023-24 batch students as the proposed changes in the MCM scholarship scheme will not lead to any additional financial burden on the Institution.

The MCM scholarship will be applicable on merit based only and there will be no reservation. The MCM scholarship will be paid annually to the awardee students. Students are required to apply on the prescribed application form and mention the preference of type of scheme clearly. Out of Type-1 and Type-2 schemes, only one scholarship will be given to a student, if selected. Further committee noted that recipients cannot draw any scholarship from any other sources. The proposal was placed before the FC for deliberations and financial approval.

The FC noted and approved the same with the following modifications in the proposed Type-1 and Type-2 MCM Scholarships.

- (i) Parents/ guardians total gross annual income from all sources should be Rs. 6.00 lakhs or less for both Type-1 and Type-2 MCM Scholarships.
- (ii) The number of Type-1 and Type-2 MCM Scholarships for various programmes/courses should be calculated on the proportionate basis of the total number of students enrolled in a programme/course.
- (iii) Increase the number of students in Type-2 MCM Scholarship from twenty-one (21) to forty-one (41).

For point no. (iii) mentioned above, FC approved for the additional amount of Rs. 7,20,000/- from IRG and advised to implement Type-1 and Type-2 MCM Scholarships from July/ August 2023 batch onwards.

It is proposed to connect B Block (Lecture Hall complex - I) with the Learning Resource Centre (LRC). A proposal has been prepared and the estimated cost of the proposed work is Rs 48.42 lakhs. The BWC approved the same using the institute fund.

Covering of this connecting path can be constructed by fixing the MS Pipe poles on existing columns provided with parapet walls. The roof covering will be by polycarbonate multi cell sheet fixed on MS tubular frame. A proposal has been prepared and the estimated cost of the proposed work is Rs 17.65 lakhs. The BWC approved the same using the Institute fund.

Item 47.9	To consider the estimate for construction of connecting corridor from B Block to Administrative Block First Floor

There was a proposal for construction of a connecting corridor from B Block to Administrative Block. First Floor to be constructed by fixing the MS Pipe poles on existing columns provided with parapet walls. The roof covering will be by polycarbonate multi cell sheet fixed on MS tubular frame. The estimated cost was Rs. 17.65 lakhs. The BWC approved the same using the Institute fund. The proposal was placed before the FC for deliberations and financial approval.

The FC considered the proposal and given in principle approval for the same. FC advised that a revised proposal with proper justification may be submitted for the next FC meeting.

Item 47.10	To consider and approve the proposal for Bituminous Carpeting and Repair of Internal Road for Pocket A and Pocket B of the campus
-------------------	--

The BWC approved the proposal of Rs 1,52,03,475.00 for Bituminous Carpeting and Repair of Internal Road for Pocket A and Pocket B of the campus using the Institute fund. The work may be awarded to CPWD. BWC suggested asking for a minimum 5-year guarantee in terms of Defect Liability Period (DLP)) from the CPWD. The proposal was placed before the FC for deliberations and financial approval.

The FC suggested to identify the roads not used for heavy vehicles for Bituminous Road and go for concrete roads where the usage is more. With these modifications, the FC approved the same.

Item 47.11	To consider and approve the proposal of CPWD for providing and fixing of Chairs in Auditorium and Convention Center, ABV-IIITM Gwalior

The Auditorium and the Convention Center of 1500 capacity was constructed by CPWD. The proposal of Rs 1,76,61,128.00 submitted by the CPWD for providing and fixing of chairs in the Auditorium and the Convention Center. The BWC approved the same using the Institute fund. The proposal was placed before the FC for deliberations and financial approval.

The FC deferred the proposal and advised the institute to explore the alternative funding sources for this activity like PPP mode, donation, reduced numbers of chairs, etc. for the same.



Item 47.12	To consider the proposal for design and estimate for the foundation of a Statue of Late Shri Atal Bihari Vajpayee Ji

The proposal for a statue of 9 feet of Bharat Ratan Shri Atal Bihari Vajpayee Ji was approved in the 41st BWC meeting held on 05.12.2022. It was approved in 43rd Finance Committee meeting held 21st December 2022 and subsequently approved in the 50th BoG meeting held on 22nd December 2022. The proposal for constructing RCC base structure and fixing statue of 9 feet of Bharat Ratan Shri Atal Bihari Vajpayee Ji at a cost of Rs. 29,65,479/- proposed by CPWD. The BWC approved the same using the Institute fund. The proposal was placed before the FC for deliberations and financial approval.

The FC considered the proposal and approved the same.

Item 47.13	Condemnation of the unserviceable and not working IT equipment and disposal of the same

A committee was constituted by the Competent Authority vide office order no. ABV IITMG/Reg /529 dated 19.05.2023 for the compilation, verification, and valuation of the 02nd list of unserviceable and not working IT equipment. The minutes of the meeting of the committee along with a list of 732 unserviceable and not working IT equipments (CPU-181, Monitor 247, Printer 37, Keyboard 217, Mouse 50) was placed in the 45th FC meeting for deliberations.

The FC advised for the valuation of unserviceable and not working IT equipments based on market survey for bulk auction through open bid with minimum reserve price for the above-mentioned IT equipment, list of obsolete items for condemnation as per the agenda item no. 44.11 discussed in the 44th FC meeting and other unserviceable and not working items lying unutilized in the Institute. Based on the FC advice, the committee submitted its report for the unserviceable and not working items lying unutilized in the Institute for condemnation and disposal. Minimum reserve price for all items mentioned in list 1 and list 2 is proposed to be Rs 50000/-. The report was placed before the FC for deliberations and financial approval.

The FC considered the proposal and approved the same.

FC advised to follow MoE, GoI and institute guidelines for the same and payment to the entitled faculty be made on reimbursement basis.

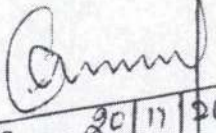

The FC noted the same and expressed the satisfaction over the expenditure.

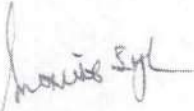

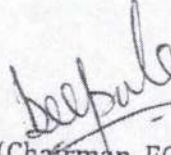
